### **10.2 Visitor and disabled car parks and parking**

- (a) Visitor car parks in the Building must not be used by Owner's or Occupiers of Lots and must only be used by genuine visitors.
- (b) An Invitee must not park or stand its motor vehicle or other vehicle in any parking spaces designated for use by visitors for any cumulative period exceeding 24 hours per week.
- (c) The Body Corporate may restrict access to visitors parking spaces by any means it deems appropriate for the purpose of regulating and enforcing the restrictions set out in (a) and (b) above.
- (d) Disabled car parks in the Building may only be used by visitors who display the authorisation or comply with the legal requirements needed to use disabled car parks in Brisbane.
- (e) You must ensure that your visitors do not park in a visitor car park for more than two hours in a day.
